## Summer Musical Theater Camp Scholarship 2017

### Our Mission

Adventure Theatre MTC (ATMTC) cultivates new generations of artists and audiences by creating memorable theatrical productions and by providing school-age students the highest quality theater and musical theater training, including the Pre-Professional Program, classes, student productions, and community engagement. Through Academy offerings ATMTC serves students at all skill levels and families from diverse communities.

The Summer Musical Theater Camp at Glen Echo Park began in 1978 and is today among the most popular and long standing summer musical theater programs for children in the D.C. Metropolitan area.

The Madeline Peeler Summer Camp Scholarship, founded in 2010, provides opportunities for young people to benefit from the highest quality performing arts and arts-related educational programming through the Summer Musical Theater Camp, which is now entering its 39th summer in Historic Glen Echo Park. The scholarship is in memory of a treasured, long time member of the ATMTC family who was an avid believer in the importance of arts education and creative outlets for children.

### Funding

Adventure Theatre MTC and the family of Mrs. Peeler are committed to serving our community and its' children, regardless of their ability to pay. Funds and resources for this scholarship are provided by Mrs. Peeler's family, friends and associates each year to allow one young person in grades 1 through 6 to attend our Summer Musical Theater Camp 2017, based on financial need and on the applicant's Declaration of Interest. Funding, in addition to the cost of the camp, includes the opportunity to participate in the before and after care programs as well as an American Express gift card in the amount of \$100 to support the student's lunches and a stipend for gas and travel.

The Madeline Peeler Summer Musical Theater Camp Scholarship is open to families whose annual gross income falls at or below the 50% median income of Montgomery County, MD. (As defined by the Maryland Child Care Resource Network's 2016 Child Demographic Report for Montgomery County <http://www.marylandfamilynetwork.org/wp-content/uploads/2015/01/Montgomery-1.pdf>). For the year 2017, the total allowable annual income for a family of four is \$54,300. ### How to Apply

Enclosed you will find the Application for Financial Aid and the Declaration of Interest, which should be completed by you and your child, respectively. Please return:

1. The completed Madeline Peeler Summer Musical Theater Camp Scholarship Application 2017;
2. Proof and verification of your annual income (a 2016 tax return, a month of payroll stubs, or W-2);
3. A supporting letter of reference from your child's arts or academic instructor about your child; and
4. A Declaration of Interest form, completed by your child.

All forms must be completed thoroughly and accurately before the application is considered complete and eligible for evaluation. The accompanying reference letter should not be completed by a family member, but should be by someone who is familiar with your child and your family. A teacher, fine arts instructor, counselor or minister would make an excellent reference.

Please Note: if you are applying for more than one child, you must submit a separate application packet for each child. If necessary, please make extra copies of the application.

All records and financial information provided are confidential and are reviewed by our scholarship committee, made up of members of Mrs. Peeler's family and the Academy staff at ATMTC.

Applications will not be accepted if postmarked after April 14, 2017. Scholarship winners will be notified by telephone or email by a member of our Scholarship Committee by May 1, 2017. You will receive a confirmation email when we have received your complete application.
